In continuation of letter No. PLG-FRDP/5-44/07-Miscellaneous-I dated
31st August, 2020, I am to say that the following text may be inserted in the para
number 4 after the word "stationery":

**" 4. , procurement of computers, printers and other ICT
hardware/office automation equipment, expenditure related to
reviewing and monitoring the progress made in the
implementation of works sanctioned under SDP, VMJS, VKVNY
and MMGPY,....."**

After inserting the above text, the para number 4 may be read as:-

" 4. The contingent fund may be used for meeting expenditure on
items like stationery, procurement of computers, printers and other
ICT hardware/office automation equipment, expenditure related to
reviewing and monitoring the progress made in the implementation of
works sanctioned under SDP, VMJS, VKVNY and MMGPY,
consumables, recurring charges on telephone/fax/computers and
other office automation equipment, POL restricted to the maximum
limit of five days during a month, during which, the DPOs are required
to make the field visits mandatorily."

Subject: Revised guidelines for maintaining & utilization of contingency amount pertaining to Decentralized Planning Programmes (SDP, VKVNY, VMJS & MMGPY)

Sir,

In continuation of letter No. PLG(F)RDP/5-44/07-Miscellaneous-I dated 31st August, 2020 and subsequent amendment in para-4 on dated 27th May 2021, I am to say that the Government has decided to amend para No. 4 of the guidelines by inserting the words/ phrases in bold and italics in the para. Now para No. 4 of the guidelines may be read as under:-

“4. The contingent fund may be used for meeting expenditure on items like stationery, procurement of computers, printers and other ICT hardware/office automation equipment, expenditure related to reviewing and monitoring the progress made in the implementation of works sanctioned under ***Aspirational District Programme (ADP)***, SDP, VMJS, VKVNY and MMGPY ***including hospitality***; consumables; recurring charges on telephone/fax/computers and other office automation equipment; POL restricted to the maximum limit of five days during a month, during which the DPOs are required to make the field visits mandatorily.”
