**Minutes of the virtual meeting held under the Chairmanship of Hon'ble Chief
Minister of Himachal Pradesh for improving Financial Management in HP on
21.05.2025**

A meeting was held under the chairmanship of Hon'ble Chief Minister of Himachal Pradesh in virtual mode, which was attended by Chief Secretary to the GoHP, Secretary (Finance), all Deputy Commissioners, Adviser (Planning) and Addl. Director (T&A).

At the outset, the Chairman of the Task Force Committee, Dr. Abhishek Jain welcomed the Hon'ble Chief Minister and other participants who were present in the meeting physically as well as virtually. The decisions taken by the Hon'ble Chief Minister of Himachal Pradesh in this meeting are as under:-

- All the Deputy Commissioners will send the separate details of interest accrued and deposited into the treasury of all heads/schemes for which funds have been provided by them i.e. Planning Head, Relief Head, etc.
- Separate details of unspent amount lying with districts as well as executing agencies of those works sanctioned before 31.03.2022 but execution has not taken place yet. These works/schemes may pertain to Planning Heads including BASP, Relief Heads, DRDA and other schemes/heads funded through State budget.
- DCs will send complete details of maintenance corpus of VMJS kept in FDs and saving accounts till date and deposited into the treasury as per the decisions taken in the previous meetings.
- All the DCs will ensure to make all inoperative bank accounts operative of various departments as per the directions issued in this regard.
- All DCs will ensure to update the MIS Portal weekly giving necessary directions to District Planning Officers/ PO (ITDP) and executing agencies to provide real time data of schemes sanctioned under Planning Heads.
- The Director (T&A) will apprise from time to time with the status of funds deposited into the treasury.

In his concluding remarks, Hon'ble Chief Minister emphasized the need to reconcile and transfer unspent funds not utilized for a long time, interest amount and funds lying in inoperative bank accounts. He also directed to supply the information before 30.05.2025.

The Hon'ble Chief Minister said that Chief Secretary to the GoHP will take next review meeting with all Deputy Commissioners.

The meeting ended with vote of thanks to the chair.
