**Subject:** Implementation of Single Nodal Agency (SNA) Model-  
Allotment of Participating Banks.

Madam/Sir,

I am to refer to the Minutes of the Task Force Committee meeting held on 09.02.2026 and the subsequent approval of the competent authority regarding assignment of Departments to the participating banks for implementation of the Single Nodal Agency (SNA) Model in respect of State Schemes.


With a view to strengthening cash management, ensuring financial discipline and improving monitoring of scheme funds, the SNA Model is being implemented in a phased manner. In continuation of the pilot implementation and based on the operational experience of the participating banks, the competent authority has approved the following allocation of Departments under Phase-II:

- **Punjab National Bank (PNB)** – Department of Horticulture, Planning Department, Jal Shakti, and Department of Economics & Statistics.
- **ICICI Bank** – Department of Technical Education, Department of Youth Services & Sports and Department of Fisheries.

The concerned Departments are, therefore, requested to initiate necessary action for onboarding/migration of existing accounts to the designated bank under the SNA framework, in close coordination with the respective bank authorities.


