Subject: Transfer of "balance available in all the inoperative government accounts" and "Unclaimed Deposits lying at DEA Fund of RBI" pertaining to the State Government to Treasury Head of Government of Himachal Pradesh – Reg.

Madam/Sir,

In inviting a reference to the subject noted above, I am to request you to deposit the balance available in all the inoperative government accounts of all DDOs and implementing agencies of the Government of Himachal Pradesh, including the amounts which have also been transferred to the Depositor Education and Awareness Fund (DEAF Fund), into the Treasury Head, the nodal department for budgeting, accounting and auditing purposes.

The Finance Department is the department which should receive back the money of the Government deposited and lying idle / inoperative in bank accounts. In this regard, I would particularly like to draw your attention to the nationwide campaign launched by the Hon'ble Union Finance Minister on 4th October, 2025, titled "Your Money Your Right". These funds may be deposited into the Treasury Head of Government, the details of which are as follows:

(Head Account Details)

Major Head :-0075-Misc. General Services-101-Unclaimed Deposites

This authorization may be treated as a substitute for undertaking individual KYC updates of each Government-related inoperative account and DEAF (unclaimed deposit) account. The State shall also facilitate **post-facto reconciliation with individual banks**, ensuring full regulatory compliance and audit trail, if any such cases arise.

The State Government hereby assures the RBI / Banks that any amount later found to be not legitimately belonging to the State or wrongly claimed shall be duly refunded to the RBI / Banks without demur.

It is therefore requested to take necessary action for deposit of these funds at the earliest. Confirmation of such transfer may please be sent to the Finance Department as and when such funds are transferred, by email at finsecy-hp@nic.in.
